**Validity conditions:**

- 5.4. The supervision over the proper function of the quality management system at the manufacturer TÜV SÜD Czech carries out pursue of the concluded contract on the control activity during the stated time according to the requirements of the standard.
- 5.5. The validity of this certificate is conditioned by functioning system of quality management in welding pursuant to ČSN EN ISO 3834-2 (ČSN EN ISO 3834-3) standards.
